→ What is the purpose of this theme for the project of an entrepreneur?

The purpose of this module is giving the entrepreneur the necessary tools to gain acknowledge about legal issues and governance that will be applied in his/her business, giving a European perspective of the situation in Europe.

17 OBJECTIVES AND COMPETENCES

What will the participant learn with the contents proposed in this module ?

The participant will know basic concepts of legal form and governance, which are the Legal Forms in each country, how to apply the Legal Form in their own project, how to create the status of the company, introduction to European Taxes and Social Standards, how to find information about legal structure in EU countries, administrative procedures in EU countries and existing devices to accompany entrepreneurs.

What are the expected results of the programme ?

During the project, 2 different programmes of 3 days have been created. The trainer or facilitator will choose the most suitable for their purposes or will combine both programmes to obtain the most accurate training for the profile of participants.

1. Participant having an idea in a first draft phase (beginner) :

This programme is more focused to participants who already have a project and need to know more in deep how to give an European perspective to his/her project and which are the legal and financial opportunities existing at that level.

The expected results of this programme are as follows :

- Brief idea of the History of Europe trade and economy,
- Distinguishing legal procedures in different EU countries,
- Know how to find information about legal procedures and financing devices in EU,
- ✓ What is a European Company.

2. Participant having a structured business idea with a defined implementation plan (advanced):

We can consider that this programme is more suitable for participants who have just a project idea.

The expected results of this programme are :

- Getting to know basic concepts of legal form and governance,
- Getting familiarised with the Business Library,
- What is a Legal Form and how to apply,
- What is the most suitable legal form of each business idea.

→ What are the expected results of the program ?

1) Get familiarised with the eu concepts of legal form and governance

2) Acquire new tools to search information

Know where to find the needed information and use it in benefit of the own project.

3) Give to the project an approppriate legal status

- Think about the possible ways of governance in the entrepreneur's project,
- Decide the most suitable legal form for the entrepreneur's project,
- Adapt the own project to both governance and legal form chosen,
- Adapt both governance and legal form of the project to the EU context.
